The 2021 6 Hour Race was \$1.5k down on profit from previous years with lower entries in both the schools and family teams. Next year we will hold the race on the 10th of April to avoid school holidays, Mothers Day and the opening of duck shooting that were all possible factors in the lower number of entries.

Chocolate Fish races have been well attended with more children and their parents attending. These will be held fortnightly again this year and Jason will organise social rides on the opposite weeks once we are back in level 1. \$5 for non members – need to encourage these people to join the club.

We could have a QR code for donations through Giv2 or similar – these could be posted at the skills park and at locations around the track entry points.

Opening night will be held in 2 weeks time on Tuesday 19th October.

We pay affiliation fees to Cycling NZ per membership which cover national numbers for those who race in national events and also cover us for insurance for races and events that the club holds.

The track south of Trevors Road to the beach is going to be repaired by Grant Hood and part of the track will be widened. James to put drone up and see how far needs to be cleared from Gibsons Road to Croys Road then ask Ecan if they can sort this.

James thanked Neil for his contribution to the club during his time on the committee.

2021 Presidents report

After covid coming through last year and cancelling our 6 hour race, many of us were probably hoping 2021 would be nicer to our club and things were looking good until we had the 1 in 100 year flood. Another set back that caused serious damage to the MTB Loop and River Walkway. The damage looked pretty bad causing some other groups that maintained track along the river to all but give up and even staff at council told some groups to abandon their sections of track as they were too costly to repair. But our volunteers weren't going to accept closure of the MTB Loop and soon got stuck into the repair job. Roughly 1000 hours of volunteer labour later, we are stoked to have our track fully reopened and in a pretty good state. Massive holes were filled in, kilometers of silt were shoveled off the surface, fallen trees were cut, berms were rebuild and new clay was laid. It was an unwelcomed event but has brought the MTB community together, made new connections between members and thanks to the give-a-little page and other donations, put us in a pretty good place financially. The committee has just ordered \$40,000 worth of repairs and enhancements.

Flooding aside the committee has achieved a lot again in the last year. Bendibus, our new 700m section of MTB track was built by volunteers over the summer and has drawn many positive comments. The machine hire was kindly funded by trail fund. This track was damaged by the flood but is now rideable again and due to have a new surface laid.

Another project that has been in planning for several years - the Riverside/ACL walkway and improvements to the MTB Loop was completed this month with funding from the Community Trust of Mid and South Canterbury. This has also drawn many positive comments from the community. It also finally gave us vehicle access from the Skills Park to SH1. It was a big undertaking, requiring weeks of work from D&E, weekend after weekend of volunteers labour, a lot of machinery and donation of concrete panels, concrete pipes, clay and hard fill.

ACL continues to be vital to the success of our projects. We can't thank them enough for the ongoing support they provide us and the tens of thousands of dollars they save us.

The Skills Park continues to grow as a community assets used by many. Our oldest native plants have been in the ground for 3 years and look awesome. From the road the Skills Park has a lot of appeal. Our pump track is soon to be asphalted, something many of us have been excited to do since it was created. This will reduce the maintenance requirements and hopefully make it faster and more exciting to

ride. We have also began to create a new area of drops at the back of the skills park. The plan is to have 4 progressive heights to cater for beginners right through to expert riders. A new shelter has also been constructed. This is part of creating a central hub in the park, eventually joined with an info board, seating, bike stands and more garden.

We have continued to work with ADC to get them on board with our cause and show them what a great asset our tracks are to the whole community. We have formed some new relationships with staff there but unfortunately lost that of one of our best contacts Craig Goodwin who has moved on to a new job.

We made a submission to the long term plan hoping that council would reinstate a budget for the Ashburton Hakatere river trail. We requested \$40k to be shared around the various groups who manage trails along the river. The council response was \$10k for the group annually for the next 10 years. This was a small success but somewhat disappointing and shows a lack of understanding by the council in regards to how popular the river recreation areas really are and how much work goes into them.

As every year there are too many people to thank but I'll start with the committee who as always have been working away in the background putting in many more hours than most people would realize. While we don't usually try and name all the volunteers a special mention must be made to Graham Russell who recently retired only to find himself helping out down the tracks on at least a weekly basis. Graham has saved us a lot of money and ticked off many of those jobs that would never get done otherwise. Finally a thank you to our sponsors and funders. We could not operate and have tracks at such a high standard without the money we receive from these generous organizations. A full list can be found at the bottom of our website.

I look forward to seeing what our new committee can achieve in the next 12 months. Fingers crossed the clock has reset for the 1 in 100 year flood.
